Joel Kramer is a dear friend of mine for over 25 years. When his accuser alleges these flat-out lies against him and the media was in a frenzy, I spoke with Joel on 1/13/18 and he said that several Media folks are going to call me, and nobody called me. I do remember Eliza running around the set like a spoiled little brat as no one could control her. I don't remember her ever getting hurt while we filmed in Florida.

Joel has been a good loyal friend and I know he treated her like his own daughter. I still cannot fathom how she can remember in such fabricated detailed story what she alleges happened 25 years ago. She told her parents, two adults and one of her older brothers and yet, no one seemed ready to confront this subject? More lies from her. She creates this heinous story in the present time of 2018, yet they (Some of her family) now back her up 25 years later because of the fabricated lies she created in which of course now makes them all look bad.
